#### 81<sup>st</sup> Pearl Harbor Memorial Ceremony (Dropping of the Roses)

The ceremony was held at the American Airpower Museum in Farmingdale on Wednesday, December 7. Special recognition was given to eighteen World War II veterans in the form of proclamations presented by Suffolk County Executive Steve Bellone and New York State Senator John Brooks.

Other distinguished guests included the Chaplain for the 106th Rescue Wing LTC **Brian McNamara**, Director of Logistics for the New York Air National Guard Headquarters COL Paul Salas, American Airpower Museum President **Jeff Clyman**, Skytyper Pilot **Tom Daly**, New York State Assemblyman David McDonough, Nassau County Executive representative Jay Rosenbaum, President and Co-Founder of Mission Margraten Plus Roger Kilfoil and Vice President and Co-Founder of Mission Margraten Plus Stephanie Folwell.

After the roses were blessed, the colors were retired, and the indoor ceremony ended, eighty-two roses (eighty-one red roses and one white rose for 9/11) were presented to the pilots of the Skytypers. Due to the overcast sky, the pilots flew the following day to drop the roses over the Statue of Liberty at 12:55 PM to mark the exact time of the Pearl Harbor attack.

#### Nassau County Veterans Support Grant Program

The Nassau County Veterans Support Grant Program funds are potentially a one-time \$10,000 payment granted to eligible 501(c)(3) and 501(c)(19) veterans' posts or organizations located in Nassau County that experienced economic hardship due to the COVID-19 pandemic. #### **New Suicide and Crisis Hotline Phone Number**

Effective July 16, 2022, 988 is the new Suicide and Crisis Lifeline number, which offers 24/7 call, text and chat access to trained crisis counselors who can help people experiencing suicidal, substance use, and/or mental health crisis issues, or any other kind of emotional distress. People can also dial 988 if they are worried about a loved one who may need crisis support.

Veterans can use this new option by dialing 988 and then pressing 1 to contact the Veterans Crisis Line.

#### **Veteran Functions at Eisenhower Park**

All veterans organizations that wish to hold an event, ceremony or other function at the park must contact the Nassau County Veterans Service Agency to get a permit. This requirement protects the organization as well as the park since the NCVSA holds an insurance policy covering any accidents or injuries that may occur during such events. #### **Veterans Traffic Court (Nassau County)**

The Nassau County Traffic and Parking Violations Agency (NCTPVA) holds monthly traffic court sessions (on the third Thursday afternoon of each month) dedicated to assisting veterans and activeduty military members with resolving violations. NCTPVA will work with the District Court to bundle all traffic violations together. This program is a one-time-only opportunity so don't waste it on minor

#### **Veterans Treatment Court (Nassau County)**

U.S. military veterans charged with relatively minor nonviolent offenses may qualify for reduced charges or penalties by participating in a court-supervised treatment program. To apply, a pre-screening questionnaire must be completed and forwarded to the district attorney's office. You must then contact the Veterans Treatment Court Project Director to set a clinical evaluation for the purpose of determining treatment needs. If you are found to be eligible, you will be contacted by the D.A.'s office and a plea offer will be proposed. # id you know . . .

American WWII fighter pilot Louis E. Curdes was not only an ace but was one of the few pilots who shot down an aircraft from each of the three main Axis air forces. Curdes earned his ace status within a month of being assigned to the 82<sup>nd</sup> Fighter Group, 95<sup>th</sup> Fighter Squadron in the Mediterranean in

April 1943. Flying a P-38 Lightning over North Africa, he shot down five German Bf-109s and damaged a fifth. Over the next two months, he also shot down an Italian Macchi C.202 over Sardinia and two more Bf-109s over Italy. In late August 1943 he himself was shot down during combat with German aircraft over Salerno, Italy. He was captured by the Italians and was sent to an Italian POW camp near Rome. Luckily for Curdes, Italy signed an armistice with the Allies just a few days later. In response, Germany invaded Italy, but before the Germans could take control of the camp, Curdes and several other prisoners escaped. After being returned to the U.S., he opted to return to active duty and was sent to the Pacific, where he was assigned to the 4th Fighter Squadron and 3rd Air Commando Group in August 1944. This time flying the P-51 Mustang, he took part mostly in ground-attack operations and escort duty for Allied shipping. On February 7, 1945, he encountered a Japanese Mitsubishi Ki-46 reconnaissance aircraft about 30 miles southwest of Taiwan and shot it down, completing the trifecta.

But as the late TV pitchman Ron Popeil often used to say, "But wait, there's more!"

On February 10, 1945, Curdes was returning to his home base after a mission to Taiwan, flying with a group of three other planes. On their way back, the group split in two, with Curdes flying with Schmidtke, and Scalley and La Croix in the second group. Over the Philippine island of Batan (not Bataan, a province on the island of Luzon and the location of the infamous Bataan Death March). Scalley and La Croix spotted a small Japanese airfield on Batan and attacked it, while calling for reinforcements. La Croix was shot down during the attack. In the meantime, Curdes and Schmidtke had flown back to join them and saw that La Croix had survived and had even launched his life raft after ditching in the sea. Curdes decided to remain in the area to guide a rescue plane and to protect La Croix.

As he was circling, he noticed a larger plane that looked like it was preparing to land at the Japanese airfield. When he got closer, he saw it was an American C-47 and he tried to contact it on his radio—no response. He then flew in front of the C-47 several times trying to get it to alter course—no effect. Curdes, thinking it was better to shoot down the C-47 at sea rather than allowing it and its crew to be captured by the Japanese, fired at its engines, disabling them and forcing the pilot to ditch in the ocean.

Fortunately, the plane managed a safe water landing, and the crew and passengers evacuated into a life raft. La Croix, the downed P-51 pilot, approached the raft and was pulled aboard, where he was apprised of the C-47's situation. The plane had gotten lost in bad weather and its radio had stopped working. It also was running low on fuel so when it saw the airstrip, it headed toward it, being unaware that it was under Japanese control. Curdes, with the sun going down and running short on fuel, was forced to return to base. The next morning, he accompanied the PBY rescue plane to pick up the raft's occupants, which included La Croix and all twelve people from the C-47, including two nurses. To add to the weirdness of the situation, Curdes was surprised to learn that one of the nurses was a woman with whom he had had a date the night before the incident. She (Svetlana Valeria) and Curdes got married on April 2, 1946 and remained married until Curdes's death on February 5, 1995 at the age of 75. His widow died on October 10, 2013 at the age of 87.

#### Lt. Quentin Roosevelt Cadet Squadron NER NY-288, Civil Air Patrol

If you have ever attended any of our various ceremonies, you have no doubt seen the young men and women in uniform holding proclamations, escorting people to receive their awards, etc. They are members of the Lt. Quentin Roosevelt Cadet Squadron NER NY-288 of the Civil Air Patrol, who have been helping our chapter for as long as I can remember.

Civil Air Patrol (CAP) is a congressionally chartered, federally supported nonprofit corporation that serves as the official civilian Auxiliary of the United States Air Force. CAP has squadrons based throughout the country and Puerto Rico, where teen cadets and senior (adult) members offer non-combat support for the USAF.

CAP activities include both air and/or ground search missions, rescue missions, disaster relief and homeland security missions. Cadets, working as a team, are trained in and offer support in non-combat missions of the USAF, such as ground and aerial Search and Rescue, Homeland Security, DEA Enforcement, and Border Patrol. The squadron covers all of Nassau County, with cadets representing all three Nassau County towns of Hempstead, North Hempstead and Oyster Bay, as well as other neighboring areas.

Students from age 12 to 18 are welcome to join, with some staying on as adult (senior) members. The cadets get to experience orientation flights on single-engine aircraft, emergency services training, drill team and color guard opportunities, encampments, as well as other cadet special activities throughout the country and possibly internationally and community service credit which can be utilized for school honor societies and other school needs.

Lt. Quentin Roosevelt Cadet Squadron NER NY-288 has been a Quality Unit Award Winner for eight consecutive years from 2015 through 2022; the Long Island Group Squadron of the Year for 2015, 2017 and 2019; the Long Island Group Squadron of Distinction for 2018 and 2021 and the Cyber Patriot XIII Second Place Silver Tier Award Winner.

This award-winning Squadron meets weekly at the Church of St. Jude (Episcopal), 3606 Lufberry Ave. in Wantagh every Monday evening from 7:00 PM until 9:30 PM. ## Taps

**Joseph J. (Joe) Ingino** of Lindenhurst passed away on December 3 at the age of 74 from the aftereffects of Agent Orange. An Army veteran, Joe was in the First Infantry Division (the Big Red One) in Vietnam in 1969-1970. His meritorious service earned him the National Defense Ribbon, the Good Conduct Medal, the Vietnam Campaign Medal, the Vietnam Cross of Gallantry and the Army Commendation with Oak Leaf cluster. Joe was a long-time advocate for Agent Orange exposure awareness, which earned him the nickname "Preacher." Joe was a long-time board member of the New York State Veterans Home in Stony Brook and a member of Vietnam Veterans of America LI Rolling Thunder Chapter 6 as well as several other veterans organizations. In 2010 he was inducted into the New York State Veterans Hall of Fame. Joe is survived by his wife Joan; children Annmarie, Joseph, Stephanie, Lisa and Katy; grandchildren Bryan, Isabelle, Anthony, Charlie, Josephine, Salvatore, Giuliana, Angelina, Lauren and Dominic along with daughter-in-law Loni and sons-in-law Charlie, Phil and Angelo.

Murray Dollinger of Melville passed away on November 3 at the age of 95. Murray was a World War II Navy veteran who lied about his age (he was 17) to enlist and who served as a radar operator in the Pacific on the USS Rawlins, a troop transport ship. After the war, he got his accounting degree under the GI Bill and afterwards worked as an auditor for the Department of Defense and as a comptroller for Mitsubishi and the Milton Paper Company. He eventually started his own accounting practice and worked there for over 40 years until he was 92, after which his son Jay took over the business. Murray is survived by his two sons, Jay and Steven (who has his own law office), as well as his daughter Lisa Antos, twelve grandchildren and four great-grandchildren. His wife, Gloria, died in 2018.
