We are still accepting applications for both the Vietnam 50th Anniversary Commemorative Medal Ceremony as well as the Women's Military Service Medal Ceremony. The requirements for each are:

Applies to both medals:

- Currently living in Nassau, Suffolk, Brooklyn, Queens, or Staten Island
- Can attend the ceremony (awards are presented **only** at the ceremony; they are not mailed)

Applies only to Vietnam 50th Anniversary Commemorative Medal:

Served in the Vietnam theater of operations in any branch of the military as per DD Form 214

Applies only to Women's Military Service Medal:

Female veteran **or** currently serving in any branch of the military as per DD Form 214 for veterans, or ID or other documentation for those currently serving.

You will find both applications at the end of this newsletter. You can also apply online from our website at LIAFA.org (DD214 and other required documentation must still be mailed; black out your Social Security number).

4th Women's Military Service Medal Ceremony

Twenty-seven veteran and active-duty women were awarded the Women's Military Service Medal on Saturday, April 26, at the Cradle of Aviation Museum in Uniondale. Annual Patchogue-Medford High School AFJROTC Awards Ceremony

On Friday, May 9, Unit NY-093 of the Air Force Junior Reserve Officers' Training Corps (AFJROTC) at Patchogue-Medford High School held its annual banquet at the Holbrook Country Club. These banquets include a buffet, speeches, dancing, drill performances and awards.

The AFJROTC program at Patchogue-Medford High School has been around since 1974. A military commitment is NOT a requirement, although those who do wish to enlist in the military after high school can receive a higher rank. The classes are an elective and are offered for all four years of high school. Joining the program provides a credit towards graduation, provides credit towards college-level ROTC programs and allows students to compete for scholarships. The Cadets learn self-discipline, citizenship, a sense of responsibility, as well as the curriculum that includes Aerospace Studies, Leadership and Management, and Health and Wellness.

The winner of the AFA Outstanding Cadet of the Year Award for the Patchogue-Medford AFJROTC unit was Unit NY-093 Deputy Commander Hope Gogarty, who received a medal, ribbon, certificate and a check for \$250 from LIAFA.

Long Island National Cemetery Memorial Day Flag Placement

Volunteers from veterans groups, scouts, schools, sports teams, bike clubs, firehouses, hospitals, local businesses and more came to the Farmingdale cemetery on Saturday, May 24, to honor the veterans interred there by planting American flags at their graves in this annual event. Thanks to their hard work, the flagging of the entire cemetery was completed in just a few hours. All participants received a patch from LINCMO, the nonprofit Long Island National Cemetery Memorial Organization.

Nassau County V-E (Victory in Europe) Day Celebration

Nassau County, in conjunction with Old Bethpage's Museum of American Armor, hosted a parade on Saturday, May 24, in Eisenhower Park to mark the end of the Second World War in Europe (the official date of V-E Day observed by the U.S., the European Union, the UK, Norway and Ukraine is May 8, 1945).

The hundreds of spectators lining the parade route were treated to the sight of seventeen period vehicles used by the Allies during World War II, including an M4 Sherman tank and an M3 half-track armored personnel carrier.

Reenactors from the Long Island Living History Association representing World War II GIs marched alongside the vehicles while Staten Island resident Luke Boyd, a Winston Churchill living historian, lent even more of a WWII "feel" to the proceedings.

Also at the event were at least two World War II veterans: Army veteran Dominick Critelli, 104, of Floral Park and Navy veteran Arthur Grabiner, 99, of North Flushing, Queens.

<u>Hicksville Veterans Association Makes Major Donation to LIAFA</u>

Vincent Morreale, president of the Hicksville Veterans Association and a Vietnam veteran, made the donation to Fred DiFabio, president of LIAFA and to several other veteran organizations, in accordance with its charter. Hicksville Veterans Association was the legal name of the Massapequa VFW, which recently dissolved and sold its building, mainly due to declining membership. Thank you, Hicksville Veterans Association, and thank you, Vinny for your generous and thoughtful donation to LIAFA!

Navy Seeks Interviews with Former Grumman Employees at Calverton

The U.S. Navy is requesting interviews with former employees, or their surviving family members, who worked at the Grumman-operated Naval Weapons Industrial Reserve Plant in Calverton between 1954 and 1996. These interviews will aid in the Navy's environmental remediation at the site, which covers approximately 6000 acres.

Since Grumman vacated the premises in 1996, the site has been a subject of controversy over chemical contamination, with dangerous chemicals such as perfluoroalkyl substances (PFAS) and 1,4-dioxane that have leaked into the Peconic River and threaten the groundwater in the area.

The Navy said it is particularly interested in employees' knowledge of:

- Past operations and activities
- Waste management practices
- **Building utilization**
- Grounds maintenance
- Aircraft fabrication practices on site
- Any other relevant information, both on- and off-property.

Participation in the interviews is completely voluntary and all information shared during the interviews will be kept confidential.

Veteran Functions at Eisenhower Park

All veterans organizations that wish to hold an event, ceremony or other function at the park must contact the Nassau County Veterans Service Agency to get a permit. This requirement protects the organization as well as the park since the NCVSA holds an insurance policy covering any accidents or injuries that may occur during such events. Veterans Traffic Court (Nassau County)

The Nassau County Traffic and Parking Violations Agency (NCTPVA) holds monthly traffic court sessions on the third Thursday afternoon of each month, dedicated to assisting veterans and active-duty military members with resolving violations. NCTPVA will work with the District Court to bundle all traffic violations together. This program is a one-time-only opportunity so don't waste it on minor violations. Veterans Treatment Court (Nassau County)

U.S. military veterans charged with minor nonviolent offenses may qualify for reduced charges or penalties by participating in a court-supervised treatment program. To apply, a pre-screening questionnaire must be completed and forwarded to the district attorney's office. You must then contact the Veterans Treatment Court Project Director to set a clinical evaluation for the purpose of determining treatment needs. If you are found to be eligible, you will be contacted by the D.A.'s office and a plea offer will be proposed. Nassau County Veterans Service Agency Transportation Program

This program provides free transportation for scheduled VA medical appointments. The veteran will be picked up at his or her residence and driven in a Nassau County Veterans Service Agency vehicle to a designated VA facility. Locations that are serviced for transportation are:

- VA Clinic, East Meadow
- VA Clinic, Valley Stream
- VA Vet Center, Hicksville
- VA Main Hospital, Northport

All appointments for transportation are required to be reserved two weeks prior to your scheduled VA appointment. Please call Jessica DeLisi (VSA Transportation Coordinator) at (516) 572-6526 to schedule transportation.

The Nassau County Veterans Service Agency is looking for volunteers to transport veterans to and from the aforementioned VA facilities. Please donate any time you have to give on Monday-Friday from 7:00 AM to 5:00 PM You pick whatever times and dates work for you. Nassau County will provide the vehicles; a valid New York State driver's license is required. To volunteer, please call Jessica DeLisa at (516) 572-6526. VetMart Food Pantry

The VetMart food pantry at the Nassau County Veterans Service Agency is located at 2201 Hempstead Tpke., Building Q, East Meadow. Building Q is located on the property of the Nassau University Medical Center (NUMC), around the back of the property.

Veterans may register at the food pantry for eligibility with a Veterans ID Card or DD214 Military Discharge Form. (Note: Other forms of veteran identification may be accepted, but eligibility will be at the discretion of the agency). Once registered with the proper veteran documentation, the veteran may come to the food pantry once per week for food distributions; toiletries and other supplies are issued monthly. The Veterans Food Pantry is open Monday through Friday from 9:00 AM to 12:00 PM (closed Weekends and Holidays). For more information/questions about the food pantry or directions to the facility, veterans may call (516) 572-6565.

Nassau County VSA Outreach Events Available

VHUC Veterans Transportation Program

From Sal Polito's "Veteran's Column" in the February 12-18 issue of the Massapequa Herald:

Through the Veterans Health Administration (VHA), the VHA-UBER Health Connect (VUHC) program offers another way for eligible veterans to access transportation to VA-authorized appointments. To qualify, veterans must meet the following criteria:

- Be service connected for 30% or more
- Be traveling to/from treatment for a service -connected condition
- Receive a VA pension or disability
- Have an income that does not exceed the maximum annual VA pension rate

Nassau County Transportation Program by GoGo

The Nassau County Office for the Aging, together with the New York State Office for the Aging, are piloting this program in Nassau County to serve senior veterans. Trips may be to medical appointments, including to the Northport VA Medical Center.

How to use GoGo:

- 1. Call the Nassau County Veterans Service Agency at (516) 572-6526 to register.
- 2. Applications will be processed within 48 hours.
- 3. Office for the Aging will call you with approval.
- 4. Once you are notified of approval, call GoGo Grandparent at (855) 464-6872 to set up your ride.

The Military Star card is a line of credit and its benefits are exclusively available to military personnel and their families, DoD civilians, Purple Heart recipients and Disabled Veterans. Veterans who received an Honorable or General under Honorable Conditions Discharge have online shopping privileges only.

Commissary Reopening

For those of you who may not already know, the Mitchel Field Commissary reopened for business on March 4 after undergoing necessary repairs. The address is West Road, Building 84, Garden City.

You are eligible to shop in a commissary if you are an active-duty service member, a member of the Guard or Reserve, a military retiree, or a veteran with a Veteran Health Identification Card that shows at least one of the following:

- Service-connected
- Medal of Honor
- Purple Heart recipient status
- Former prisoner of war (POW)

If you're a family member, one of these must describe you:

- Surviving spouse of a service member (if you haven't remarried), or
- Primary family caregiver of an eligible Veteran (recognized under the Program of Comprehensive Assistance for Family Caregivers), or
- Dependent or survivor of an eligible service member, or
- Dependent of an eligible member of the Reserves

Lifetime Liberty Pass for New York State Residents

Since April 1, 2024, eligibility for the Lifetime Liberty Pass has expanded to encompass the following (for New York State residents only):

- 1. All veterans, regardless of whether they have a VA disability compensation rating and who were discharged or released from service under conditions other than dishonorable.
- 2. Gold Star parents, Gold Star spouses and Gold Star children.

This pass provides free admission to all New York State parks. Additionally, pass-holders are also entitled to free admission to the two Town of Hempstead golf courses in Merrick (9 holes) and Lido Beach (18 holes).

To apply for the Lifetime Liberty Pass, please go to the following website: https://www.parks.ny.gov/admission/lifetime-liberty-pass.aspx.

Also, since April 1, 2024, a veteran who has the veteran distinguishing mark on their New York State driver's license or nondriver's ID card will be able to use that license to gain free admission at New York State parks that have a *staffed* admission gate. Parks that have only an *unstaffed* admission kiosk, however, will require the use of the Lifetime Liberty Pass.

PACT Act and Camp Lejeune Justice Act (CLJA) Deadlines

The information below is from an article by Elizabeth Hartman of the law firm Bergmann & Moore LLC in the October 2023 issue of *The American Legion Magazine*:

There is no deadline to file a PACT Act claim through the VA. You can always contact an accredited American Legion service officer to file a claim. The "deadline" that is shown on several law firms' websites references filing an Intent to File (ITF). If you had filed an ITF by 11:59 PM Eastern Time on August 14, 2023, that ensured that your benefits (if ultimately approved) would have dated back to the implementation date of the PACT Act-August 10, 2022-in essence, giving you a bonus year of benefits and a year from the date of the ITF to finalize your claim. There is no deadline for filing the PACT Act claim itself. Your claim will simply be considered from the date you filed rather than from the implementation date.

More PACT Act Information

The VA has announced that all veterans who were exposed to toxins and other hazards while serving are eligible to enroll in VA Healthcare. This means that all Vietnam War, Gulf War, Iraq, Afghanistan, the Global War on Terror or any other combat zones after 9/11 are eligible to enroll directly in VA Healthcare without first having to apply for benefits. For more information on the PACT Act, presumptive conditions and locations, visit www.va.gov and search on PACT Act, or call the Nassau County Veterans Service Agency at (516) 572-6565 or the Suffolk County Veterans Service Agency at (631) 853-8387.

Here is a list of "presumptive conditions," which are conditions that the VA automatically presumes were caused by your service:

These cancers are now presumptive:

- Brain cancer
- Gastrointestinal cancer of any type
- Glioblastoma
- Head cancer of any type
- Kidney cancer
- Lymphoma of any type

- Melanoma
- Neck cancer of any type
- Pancreatic cancer
- Reproductive cancer of any type
- Respiratory (breathing-related) cancer of any type

These illnesses are now presumptive:

- Asthma that was diagnosed after service
- Chronic bronchitis
- Chronic obstructive pulmonary disease (COPD)
- Chronic rhinitis
- Chronic sinusitis
- Constrictive bronchiolitis or obliterative bronchiolitis
- Emphysema
- Granulomatous disease
- Interstitial lung disease (ILD)
- **Pleuritis**
- Pulmonary fibrosis
- Sarcoidosis

If you don't have any of these presumptive conditions, you can still qualify for VA benefits, but you'll need added documentation to prove your case.

Their mission is to boost the morale of service members wounded in the line of duty. The NCFF-OWW works closely with military representatives of the Walter Reed National Military Medical Center in Washington DC, the Womack Army Medical Center in Fort Liberty, NC and the Naval Hospital in Camp Lejeune, NC. - Every Guardian must be between 18-66 years of age or be in peak physical condition and able to handle the rigors of the day (i.e. pushing a wheelchair, extensive walking, bad weather).
- Guardians pay \$400 for the privilege to escort these veterans to D.C.
- Guardians DO NOT need to submit the \$400 donation until it is your turn to fly.
- Guardians will be contacted by Honor Flight Long Island when they have been scheduled for an upcoming flight.

RISE Study Regarding Veterans and Stress

The ReACH (Relationships, Aging, Coping & Health) Lab at Adelphi University has launched the RISE (Relational Influences on Sleep & Emotion) Study to learn more about how veterans cope with stress in their daily lives and how it affects their sleep and well-being. They are looking for veterans who are at least 65 years old and are married (or living with a partner). Participants will be compensated for their time and effort with a maximum of \$75 worth of gift cards. Participation includes an initial survey and seven brief daily surveys that will be emailed to you, along with the *option* to wear a watch-like device (after visiting their lab) to help them measure your sleep. The study runs through December 31, 2025.

Free COVID-19 At-Home Test Kits—***No Longer Available***

As of March 10, 2025, you can no longer request free COVID-19 at-home test kits from the government through the website https://covidtests.gov. Last August, health officials said that the national stockpile of COVID-19 tests was large enough to sustain the program. It is unclear what inventory now remains in the national stockpile and what will happen to the unused test kits.

It's recommended to get the updated 2024-2025 COVID-19 vaccine to help protect you from severe disease, hospitalization and death; the vaccine is recommended by the CDC for most adults ages 18 and older. Parents of children ages 6 months to 17 years should discuss the benefits of vaccination with a healthcare provider. It is especially important to get your 2024-2025 COVID-19 vaccination if you are age 65 or older, are at high risk for severe COVID-19, or have never received a COVID-19 vaccine. Vaccine protection decreases over time, so it is important to stay up to date with your COVID-19 vaccine.

MedEquip Medical Alert Device with Monitoring-FREE for Veterans

This device (available as a pendant or a wristband) with Stat-VA data is the only medical device of its kind that incorporates veteran health information. All you need to do is press the button and a responder will know who and where you are and handle the rest. You do not need to have a pre-existing condition to qualify.

id you know . . .

... that a Boeing KC-135 Stratotanker aerial refueling aircraft once literally exploded and was damaged beyond repair after a routine cabin pressurization test?

It happened on April 7, 1999. The plane was assigned to the 153rd Air Refueling Squadron of the 186th Air Refueling Wing, Mississippi Air National Guard and was undergoing maintenance at the Oklahoma City Air Logistics Center at

Tinker AFB, Oklahoma. According to an excerpt from a military "lessons learned" presentation that appears on http://www.discity.com/kc135/, "a KC-135 aircraft was being pressurized at ground level. The outflow valves, which are used to regulate the pressure of the aircraft, had been capped off during a five-year overhaul and had never been opened back up. The post-investigation revealed that a civilian depot technician, who 'had always done it that way,' was using a homemade gauge, and no procedure." The technician's gauge didn't even have a MAX peg for the needle so apparently, in a moment of inattention, he missed that the needle had already made a 360-degree turn around the dial and he continued to increase the pressure. As the needle was now on its second trip around the dial, the fuselage violently ruptured with an explosive "boom," tearing a 35-foot hole in the aft fuselage and dropping the tail section to the ground. The rear hatch was blown over 70 yards away behind a blast fence. Amazingly, nobody was killed or seriously injured, but the multi-million-dollar aircraft was a total loss.

The previously referenced excerpt drily notes, "This is an example of what happens when we do not pay attention to detail, and do not follow instructions and checklists!"


