Veterans Annual Winter Stand Down

The annual Winter Stand Down took place on Tuesday, November 21 at the Freeport Armory. It was a drive-through-only event (with some arriving by foot) and the only items distributed were clothes, boots, toiletries, gift cards and nonperishable foods. 625 veterans came to the event and received a bag of items. All excess food was delivered to the Vet Mart run by the Nassau County Veterans Service Agency.

82nd Pearl Harbor Memorial Ceremony (Dropping of the Roses)

The ceremony was held at the American Airpower Museum in Farmingdale on Thursday, December 7. Special recognition was given to fifteen World War II veterans in the form of proclamations presented by Nassau County Veterans Service Agency Director Ralph Esposito and Suffolk County Veterans Service Agency Director Marcelle Leis.

Other distinguished guests included American Airpower Museum President **Jeff Clyman**, Skytyper Pilot Tom Daly, Senior VP, Membership & Chapters, NDIA Col. (Ret.) Rachel McCaffrey, Commander, Navy Operational Support Center Lt. Cdr. Scott Sackreiter, President and Co-Founder of Mission Margraten Plus **Roger Kilfoil**, Vice President and Co-Founder of Mission Margraten Plus Stephanie Folwell and Rabbinic Chaplain Joni Brenner.

After the roses were blessed, the colors were retired, and the indoor ceremony ended, eighty-three roses (eighty-two red roses and one white rose for 9/11) were presented to the pilots of the Skytypers, who then took off to drop the roses over the Statue of Liberty at 12:55 p.m. to mark the exact time of the Pearl Harbor attack.

Announcements and Programs

PACT Act and Camp Lejeune Justice Act (CLJA) Deadlines

The information below is from an article by Elizabeth Hartman of the law firm Bergmann & Moore LLC in the October 2023 issue of *The American Legion Magazine*:

- There is no deadline to file a PACT Act claim through the VA. You can always contact an accredited American Legion service officer to file a claim. The "deadline" that is shown on several law firms' websites references filing an *Intent to File* (ITF). If you had filed an ITF by 11:59 p.m. Eastern Time on August 14, 2023, that ensured that your benefits (if ultimately approved) would have dated back to the implementation date of the PACT Act-August 10, 2022-in essence, giving you a bonus year of benefits and a year from the date of the ITF to finalize your claim. There is no deadline for filing the PACT Act claim itself. Your claim will simply be considered from the date you filed rather than from the implementation date.
- The CLJA, included as a provision under the PACT Act, separately allows individuals exposed to toxic water at Camp Lejeune between August 1, 1953, and December 31, 1987, to sue the U.S. government for damages/benefits. There is a sunset provision in the CLJA, which means that a CLJA claim must be filed no later than August 9, 2024.

The NCFF-OWW works closely with military representatives of the Walter Reed National Military Medical Center in Washington DC, the Womack Army Medical Center in Fort Liberty, NC and the Naval Hospital in Camp Lejeune, NC. Together, they ensure that useful clothing, personal entertainment electronics, and get-well cards are properly channeled to recovering service personnel. Donations are brought down to Bethesda Naval Hospital and other Wounded Warrior centers via Fire Truck Caravan. Firefighters from throughout the Greater New York area join their 'parade' from New York to military hospitals in the south. Volunteers are also welcome to join their ranks, even if you are not a firefighter! The NCFF-OWW is comprised of firefighter and EMS volunteers throughout Nassau County who conduct numerous fundraising events throughout the year to help meet their goal of providing material and moral support to the wounded men and women of our Armed Forces. Each year's efforts culminate with a personal visit of NCFF-OWW representatives to each of the military hospitals in the area to meet with our brave wounded warriors and express their gratitude for the sacrifices that they have endured for our country. In addition to collecting items and visiting our wounded service personnel, the NCFF-OWW organizes,

Vietnam Veterans of America (VVA) Donation Programs

If you're looking to donate clothing, books, small appliances or pretty much anything else, and also want to help veterans, go to <u>clothingdonations.org</u> or call (631) 582-0242 to schedule a pick-up. Please put the donation outside before 7 a.m. on the scheduled pickup date, clearly marked *Vietnam Veterans of America*, so that the driver can see it from the street. VVA has found that the most profitable way to sell household discards is through bulk-purchase agreements with private retailers on a bid basis. A portion of the proceeds goes to our local Nassau County VVA Chapter 82.

Nassau County Veterans Support Grant Program

The Nassau County Veterans Support Grant Program funds are potentially a one-time \$10,000 payment granted to eligible 501(c)(3) and 501(c)(19) veterans' posts or organizations located in Nassau County that experienced economic hardship due to the COVID-19 pandemic. Veteran Functions at Eisenhower Park

All veterans organizations that wish to hold an event, ceremony or other function at the park must contact the Nassau County Veterans Service Agency to get a permit. This requirement protects the organization as well as the park since the NCVSA holds an insurance policy covering any accidents or injuries that may occur during such events. Veterans Traffic Court (Nassau County)

The Nassau County Traffic and Parking Violations Agency (NCTPVA) holds monthly traffic court sessions on the third Thursday afternoon of each month, dedicated to assisting veterans and active-duty military members with resolving violations. NCTPVA will work with the District Court to bundle all traffic violations together. This program is a one-time-only opportunity so don't waste it on minor violations. Veterans Treatment Court (Nassau County)

U.S. military veterans charged with minor nonviolent offenses may qualify for reduced charges or penalties by participating in a court-supervised treatment program. To apply, a pre-screening

questionnaire must be completed and forwarded to the district attorney's office. You must then contact the Veterans Treatment Court Project Director to set a clinical evaluation for the purpose of determining treatment needs. If you are found to be eligible, you will be contacted by the D.A.'s office and a plea offer will be proposed. RISE Study Regarding Veterans and Stress

The ReACH (Relationships, Aging, Coping & Health) Lab at Adelphi University has launched the RISE (Relational Influences on Sleep & Emotion) Study to learn more about how veterans cope with stress in their daily lives and how it affects their sleep and well-being. They are looking for veterans who are at least 65 years old and are married (or living with a partner). Participants will be compensated for their

time and effort with a maximum of \$150 worth of gift cards. id you know . . .

The first fatal airplane crash happened in the United States on September 17, 1908, when a plane piloted by Orville Wright crashed into a field after the propeller severed a rudder control wire, breaking the propeller and sending the plane into a nosedive. Orville Wright was

hospitalized with several broken ribs and a fractured thigh. The second crewmember, Lieutenant Thomas Selfridge, who was an Army observer on the flight, was killed.

The recently-crowned Miss America for 2024 is 22-year-old Air Force 2nd Lieutenant Madison Marsh. Marsh, representing the state of Colorado, is the first member of the U.S. military ever to win the national title. She is an active-duty Air Force officer and a fighter pilot, has a degree in astrophysics from the U.S. Air Force Academy, is studying at the Harvard Kennedy School for a master's degree in public policy and has a black belt in taekwondo. Marsh lost her mother to pancreatic cancer in 2018, inspiring her to start the Whitney Marsh Foundation alongside her family. She has been able to raise more than \$250,000 for pancreatic cancer research so far.

Cradle of Aviation Museum

Probably the first thing you will notice upon entering the front door of the museum is a blue U.S. Navy F-11A Tiger jet fighter that is suspended from the ceiling. The Tiger was the first carrier-based fighter with supersonic capability, due to the specially shaped fuselage, powerful engine and very thin wings fitted into the most compact airframe possible. The F-11 was armed with four 20 mm cannons and four Sidewinder air-to-air missiles and entered service in 1957. It was also used by the Navy's Blue Angels aerobatic team for more than ten years.

A tax-exempt nonprofit 501(c)(3) organization, the museum is located on Museum Row on Charles Lindbergh Boulevard in Uniondale (even though the mailing address is shown as Garden City). Its mission is to serve as an educational center preserving Long Island's contributions to aerospace, science and technology by inspiring future generations through learning. It is located on land that was once a part of Mitchel Air Force Base which, together with nearby Roosevelt Field and other airfields on the Hempstead Plains, was the site of many historic flights—so many, in fact, that by the mid-1920s the cluster of airfields was already referred to as the Cradle of Aviation, the origin of the museum's name. The museum opened in 1980 with only a handful of aircraft. A major renovation and expansion program in the late 1990s allowed the museum to re-open in a state-of-the-art facility in 2002. The building has multiple exhibit floors that encompass exhibit halls, a gift shop, a cafeteria and a planetarium. Additional expansion plans are currently under development.

Exhibit galleries at the museum include The Dream of Wings, The Hempstead Plains, World War I, The Golden Age, World War II, The Jet Age, Contemporary Aviation, and Exploring Space (which features the Grumman Lunar Module LM-13, the same type of lunar module that landed astronauts Neil Armstrong and Edwin Aldrin on the moon on July 20, 1969).

The Cradle has hosted many of LIAFA's Vietnam medal ceremonies over the years. Various veterans organizations also meet periodically in the third-floor conference room, among which are the United Veterans Organization of Nassau County (UVO), the Nassau County Veterans Advisory Board (hosted by the Nassau County Veterans Service Agency) and the Air Force Sergeants Association (AFSA).

The Cradle depends on the generosity of foundations, corporations and dedicated individuals to maintain and expand its programs and activities. You can make a donation or buy an engraved brick to be installed in either their F-14 Tomcat Plaza or Sally Ride Circle; both are 100% tax-deductible as a charitable contribution. You can also buy or gift somebody a museum membership; various membership levels are available. They are always looking for men and women who wish to volunteer a few hours each week to act as a docent/museum guide, a member of the restoration team, a gift shop cashier, an information monitor, a Junior Jet Club attendant or a host/speaker for one of the museum's educational programs. Howard Kalachman of Lynbrook passed away on November 14 at age 79 after complications from surgery. Howard was an Army Vietnam veteran who served with the 1st Air Cavalry from November 1967 to December 1968, earning a Bronze Star among other awards. He was a mortarman until he was wounded at An Khê. Howard served as a senior mentor with the Nassau County Veteran Treatment Court and had been an officer of several veterans organizations as well as the DAV representative to the United Veterans Organization of Nassau County (UVO). A graduate of Queens College, Howard was a math teacher and assistant principal with the New York City school system for over twenty years until 2006. He was also the author of the book, "Hi Mom, I'm O.K." and Other Lies From Vietnam, in which he chronicles his service with excerpts of letters, candid commentary, history and photos.

Richard A. Bellospirito of Oyster Bay passed away on December 3 at age 83; no cause of death was given. Richard was an Army National Guard veteran (1957–1965), a lifelong member of the Oyster Bay Italian-American Club and a past 1st vice commander of the Oyster Bay AMVETS Post 21. He is survived by his wife of 48 years, Marcy, their two children, Kara Hotaling and Cindi Mantegari and his brother, Eugene.

Russell Hamler of Pittsburgh, PA passed away on December 26 at age 99; a cause of death was not given. He was the last known remaining member of the famed American jungle fighting unit from World War II nicknamed Merrill's Marauders, the actual name of which was the 5307th Composite Unit (Provisional), commanded by Brig. Gen. Frank Merrill; it was composed entirely of volunteers. The unit's secret mission was to capture a Japanese-held airfield (the only all-weather strip in northern Burma) in the city of Myitkyina in Burma (now Myanmar), to cut off Japanese communications and supply lines along their long march (roughly 1000 miles) and to open an Allied supply route between India and China. They started out with 2997 soldiers in February 1944, slogged through the jungle and over steep mountains behind enemy lines, and fought five major battles and thirty minor ones (often outnumbered) before finally completing their mission in August 1944; the airfield was captured in May in coordination with elements from two Chinese infantry regiments, but the town itself held out until August 10. By the time the unit was disbanded a week later, just over 1300 members had survived, with only 130 of them considered combat-capable.

Hamler was wounded in the hip by a mortar fragment during the battle known as Nhpum Ga in April. The injury immobilized Hamler in his foxhole for more than ten days until rescuers arrived and evacuated him to a hospital in India, where he recuperated for five months and then was sent back home to Pennsylvania. He served as a military policeman until he was discharged in December 1945. He became an aircraft mechanic for Trans World Airlines and retired in 1985.

Hamler was awarded a Bronze Star and Purple Heart. He was among the handful of Marauders still living when the original members were awarded the Congressional Gold Medal in 2022.
